**Reason for objection**: We have heard news that the Cumberland Local Council is proposing to build an Organic Waste Transfer Station and as a person who lives in the suburb I strongly object to this decision. The creation of a Organic Waste Transfer Station is set to be built in an area less than 100 meters away from local residential properties, especially the new residential properties being built not even 100 meters away from the set position of this waste factory. There is not many crossings and it could hardly be considered safe for adults and especially children when there are 59 large garbage trucks with lengths of 20 metres coming and going through the waste factory, resulting in the movement of 118 truck movements. No matter how much you justify safe driving, everyone within the suburb is exponentially prone to danger.
