I am writing to Cumberland council to voice my concern of the recent DA2023/0130 proposal, and to object the Organic rubbish tip build so close to Lidcombe town center.

I am concern the "smell" and "traffic" if this proposal goes ahead with such irresponsible government planning.

Reasons for the current location are such a bad choice (Too close to Lidcombe town center):

- Within 100 meters, you have existing local residents who lived nearby on Bachell ave.
- Within 200 meters, you have new dwellings at 4-34 Church St, Dalley St & Eric Crescent.
- Within 300 meters, you have Rawson st, Martin st, Swete st, Union st, Brenda Ave, Mazepa Pl.
- Within 400 meters, you have Phillip Park which many local residents enjoy the morning walk or exercise during the day around the park and breathing the fresh air.
- Within 600 meters, you have the Lidcombe Railway Station six plat forms (27,740 passengers daily), the center of Lidcombe town center.
