
Dear

The three Blue colour circles shown below is just three example where the road is very narrow, the trucks easily can swerve causes car accident include loss of life and injuries.



All trucks and cars travel to and from the development site(109A Church Street, Lidcombe) will be generated a lot of pollution which causes irritation and weakening our body from the burning fuels from the extra trucks and cars. Also, this poses health risk to young children(many of Childcare Centre nearby) and causing asthma.
