Hi there,  
I hope this email finds you well.

I am writing to express my strong opposition to the proposed organic waste transfer station in Lidcombe. After reviewing the details of the project, I have identified several concerns that I believe should be taken into serious consideration before moving forward with this development. I kindly request that you reconsider the proposal based on the following reasons:

**1. Impact on Lidcombe's Road Network:**

The proposed transfer station will serve councils across the Sydney metropolitan area, resulting in a significant increase in waste transport through Lidcombe's road network. This will impose a considerable burden on the already strained infrastructure, potentially leading to road deterioration and increased congestion. This close proximity raises concerns regarding the potential health, safety, and quality of life for the residents. It is essential to prioritise the well-being of the community and consider the potential adverse effects that this facility may have on the residents, particularly in terms of noise, air quality, and overall livability.

#### 4. Uncertain Odor Control Measures:

While the Environmental Impact Statement and other reports may claim to address the issue of odor, there is no concrete guarantee that the proposed measures will effectively control the odors emanating from the site. The transportation of waste to the transfer station will undoubtedly generate odors that could negatively impact both the commercial entities and the adjacent residential areas in Lidcombe. Such odors could deter potential customers and residents, thereby causing economic and social repercussions for the community.

Considering these concerns, I urge you to reconsider the location of the organic waste transfer station. It is crucial that alternative sites, preferably in more suitable industrial areas away from residential zones, be explored to minimize the potential negative impact on Lidcombe's community. By doing so, we can ensure the well-being, safety, and quality of life for all residents, while also promoting sustainable development in our region.
