Dear Cumberland Council,

I am writing to express my strong objection to the proposed construction and operation of an organic waste transfer station at 109A Church Street, Lidcombe, NSW 2141; Lot 1 DP 778492 (File: DA2023/0130).

As a concerned member of this community, I deeply value the peaceful and harmonious nature of our neighborhood. However, the introduction of an organic waste transfer station would undoubtedly disrupt the tranquility we currently enjoy. With the ongoing construction of new apartments and the already bustling traffic on Church Street, the addition of waste transfer trucks circulating in the area would only exacerbate the existing congestion issues.
