Dear Council,

I live in Lidcombe for a number of years. I enjoy living in Lidcombe for its convenient facility, lovely residents, and smart council who be mindful of the common good and of the future of residents.

As discussed with my neighbours and friends living in Lidcombe, **ALL** of us express **strong opposition** to this plan - DA2023/0130 Demolition of existing buildings and construction and operation of an organic waste transfer station in 109A Church Street Lidcombe.

Reasons are below:

1. **Safety issue:** it is very **close to residential area, schools and train station**. If we build a waste transfer station in Lidcombe, **trucks are in and out**, it is **very dangerous for kids, the old and pedestrians**.
2. **Environment & Health issue:** it would **ruin local environment**, especially land and air. Moreover, it would exude a **pungent smell** in Summer and **noises from trucks** which must bring **harmful & unhealthy effects** to residents' **health and living quality**.
3. **Traffic issue:** there is **only one road (Arthur Street)** for Lidcombe residents to **go to M3**. Every morning, I need to spend at least 10 mins in Arthur Street due to traffic jam, although it is only less 200 metres !!! If we build a waste transfer station in Lidcombe, it would be more than 100 trucks in and out every day and must cause **a huge, terrible and worst traffic jam** in Lidcombe. And ratios of **traffic accidents much be significantly increased** as well!!!
4. **Economy issue:** it would **ruinously damage & disrupt local economy** due to above 3 reasons. No one want to live in Lidcombe or come to Lidcombe for shopping/eating.

If it is built, most of us must **move out Lidcombe**. Please don't **destroy our homes and living environment !!!**

Overall, there are **no any benefits but huge adverse effects** for Lidcombe. I **am violently and strongly opposed** to this idea. So **PLEASE PLEASE PLEASE DO NOT OPERATE DA203/0130 !!!**
