As a concerned resident who lives just 200 meters away from the proposed transfer plant, I urge you to carefully consider the following pressing concerns, specifically regarding the potential impact on my daily travel:

The proximity of the proposed development to my residence raises significant concerns about the disruption it will cause to my daily commute.
